LEGAL SPECIFICATIONS

According to the German Occupational Health and Safety Act (ArbSchG) and the Ordinance on Industrial Safety and Health (BetrSichV) operators are obliged to inspect the technical condition of their installed plant at regular intervals, to check the process with regard to construction design modifications and adapt it to the state-of-the-art technology. If necessary, appropriate measures have to be defined and implemented.

INSPECTIONS OF INSTALLATIONS WITH AN EXPLOSION HAZARD

prior to their first-time use and recurrent acc. to Appendix 2 / Section 3 of the Ordinance on Industrial Safety and Health (BetrSichV) by an authorised person from Herding.

RECURRING TESTS minimum requirement in accordance with the BetrSichV
(The deadlines like annual, every 3 years and every 6 years are to be adapted to the respective situation)

ANNUAL

- Inspection of the measures for avoiding of an explosion atmosphere

EVERY 3 YEARS

- Inspection of the measures for avoiding effective ignitions sources
- Inspection of the explosion protection measures with protection systems according to ATEX

EVERY 6 YEARS

- Inspection of the explosion safety-concept according to the technical-state-of-the-art
- Inspection of the operational parameters pursuant to ATEX
